MINUTES OF THE LLANDEGLA COMMUNITY COUNCIL ORDINARY MEETING HELD ON THURSDAY 2ND SEPTEMBER 2021 AT 7.30 PM VIA ZOOM CONFERENCE.

- 2. TO RECEIVE APOLOGIES FOR ABSENCE: Councillor Claire Livingston.
- 3. 'MEMBERS ARE INVITED TO DECLARE PERSONAL AND PREJUDICIAL INTERESTS IN ITEMS ON THE AGENDA. IT IS A REQUIREMENT THAT DECLARATIONS FROM A MEMBER INCLUDE THE NATURE OF THE INTEREST AND WHETHER IT IS PERSONAL OR PREJUDICIAL'. (STANDING ORDERS NO 57). Councillor Karen Bellis declared personal interest on agenda item 19A below.

4. PUBLIC PARTICIPATION SESSION.

"THIS PROVIDES AN OPPORTUNITY FOR MEMBERS OF THE PUBLIC TO RAISE QUESTIONS ABOUT AND COMMENT ON ITEMS ON THE AGENDA.

Dr. Hugo Watts reported whilst strimming the "Community Field" recently on the amount of dog waste on site which is unpleasant under any circumstances. Members resolved to complete a risk assessment of the "Community Field" with the view of the provision of adequate signage and litter/dog bins on site.

5. REPORT FROM COUNTY COUNCILLOR MARTYN HOLLAND.

- A: The County are planning this year to surface dress the section of the A542 from the Ponderosa to the cattle grid at Tai Newyddion.
- B. I have already circulated the revised X51 bus service timetable. Sadly Arriva are another company that are suffering from a shortage of HGV drivers and our thanks go to the local bus companies that have stepped up to fill the gaps in these important services.
- C. Can I just remind the Council that you need to consider how they will use the commuted sum funds? If we do not use it we may lose the funds.
- D. I had a report of fly tipping in the old quarry in Old Gate Lane. I contacted DCC who removed the offending settee the following day.
- E. I have asked the County to cut back the hedges in Old Gate Lane which have become very overgrown. The Counties contractors who cut the roadside verges etc were late starting this year but they should be finished by early September.
- F. I have received reports of cars speeding in Old Gate Lane and to help resolve this issue I have asked the County to move the 30mph limit further up the lane so that it is not missed as you enter the lane from the A525.
- G. I have chased the grass cutting and bush trimming in Trem Y Grug which has sadly become an annual event!!
- H. Garden waste was fly tipped as you enter the slip road for Old Gate Lane from the A525. I have reported this incident and it should have been removed by now.
- I. I am working with the Community and the Community Council to see if we can install planters around the village car park to replace the concrete bollards that were recently removed.
- J. the Ash Die Back survey is ongoing and I have asked the County to let me see a copy of the report as soon as it is available. Sadly we have possibly the largest concentration of Ash Trees in the County in our ward and once these have to come down it will have a massive impact on our landscape.
