2. TO RECEIVE APOLOGIES FOR ABSENCE:-

- 4. TO DETERMINE THE ESTABLISHMENT OF THE "COMMUNITY NEWSLETTER". Councillor Janet Strivens reported that the inaugural meeting of the "Llandegla Community Newsletter" Committee will meet in December and Councillor Strivens will report back to the next Council meeting. Councillor Karen Bellis reported that the Denbighshire and Flintshire Agricultural Society Press Officer would assist the "Newsletter Committee" if required.

5. TO DETERMINE THE USE OF THE FORMER TELEPHONE KIOSK IN LLANDEGLA.

No progress since the previous Council meeting, but the issue will be raised in the forthcoming recommencement of the "Community Newsletter".

<u>6. TO DETERMINE THE LLANDEGLA CAR PARK NOTICE BOARD</u> REPAIRS/REPLACEMENT.

Councillor Karen Bellis reported that Haydn Edwards has agreed to look investigate the work required on the notice board and report back prior to the next Council meeting with the necessary quotation for the works.

7. TO DETERMINE THE LLANDEGLA COMMUTED SUMS GRANT APPLICATIONS. Councillors Karen Bellis and Claire Livingston together with the Clerk met via Zoom with Mrs Amy Selby the Denbighshire Community Council Community Development Officer earlier on in the day at 4.00 p.m. Mrs Selby is the Officer link to provide information and assistance to claim the commuted sum balance of £27,392.48 that exists within the Llandegla Community Council area. Councillor Livingston reported that the Llandegla School PTA are in the process of applying for an outdoor £10,000 project which would leave £17,000 grant available for the remainder of the projects earmarked within Llandegla.

8. TO DETERMINE THE PURCHASE MEMORIAL BENCH IN MEMORY OF THE LATE BOB BARTON.

Councillor Karen Bellis reported that Meifod Wood Products Denbigh will reopen in the New Year, after which the Community Council can approach and order the "Memorial Bench" in memory of the late Bob Barton.

9. TO DETERMINE THE QUEEN ELIZABETH II PLATINUM JUBILEE 2022 CELEBRATIONS.

A. Councillor Janet Strivens confirmed that Llanrhaeadr Potteries would be able to produce "Commemorative Mugs" for the Community Council for the Queen Elizabeth II Platinum Jubilee 2022 celebrations. Members resolved to pursue with the purchase of the mugs and for the Council to determine the design required.

B. Councillor Karen Bellis reported that the Llandegla Memorial Hall Committee would host the Queen Elizabeth II Platinum Jubilee 2022 elevation event with the Community Council approval. Members resolved to accept the proposal and for the Community Council to fund the event.

10. TO DETERMINE THE PLANTERS FOR THE LLANDEGLA CAR PARK.

Following the email received from the Llandegla Gardening Club on 10th August 2021, the Members resolved to grant the Llandegla Gardening Club permission to build and erect the planters for the Llandegla Car Park and the Community Council will reimburse the Gardening Club with the costs of the planters provided.
