Councillor Terry Mendies provided his updated monthly written report as follows:- A: PLANNING BREACHES.

On Wednesday 28th June, Mr Low from Llandegla was fined £10,000 for planning breaches at Ty Isoe. He was further ordered to pay DCC legal costs of almost £17,000. Mr low has eight weeks to pay or will serve a 6-month jail term. In addition to the above a charge has been registered against his property for the sum of £25,000 being costs for clearing his property.

C: FOOTPATH QUOTES FOR TOP FIELD.

We have had a quote for less than £5,000 from Teesons in Ruthin. Once I receive the third quote, I will endeavour to secure Council funding.
